## NOTICE OF PUBLIC HEARING

The CONNECTICUT HOUSING FINANCE AUTHORITY (the "Authority") is empowered under Chapter 134 of the General Statutes of Connecticut, the Connecticut Housing Finance Authority Act, to issue tax-exempt bonds to provide financing of single and multifamily housing for eligible persons and families of low and moderate income. The Authority intends to issue taxable and/or tax-exempt bonds in one or more series, pursuant to one or more plans of financing, the amount not to exceed \$27,500,000, the proceeds of which will be used to (1) provide financing, refinancing or reimbursement for the construction, renovation or equipping of State supported community-based residential housing facilities throughout the State, as set forth below ("Group Homes") owned or to be owned by charitable organizations exempt from federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended; (2) to refund prior bonds which were issued to finance mortgage loans for one or more Group Home developments; and (3) to finance the costs of issuance, reserve funds and working capital accounts for such bonds.

The Authority will hold the public hearing on the proposed financing required by the Internal Revenue Code in its offices located at 999 West Street, Rocky Hill, Connecticut 06067 at 10:00 a.m. on April 16, 2019.

The purpose of the hearing will be to solicit comments from the general public on the issuance of bonds by the Authority and Group Homes financed thereby. Interested persons are invited to attend and will have an opportunity to make statements regarding the financing. Further information with respect to the bonds and their purpose will be available at the hearing or upon written request at the address shown above.
