# *Question: Will CHFA accept equivalent hardware that meets or exceeds proposed equipment in the Bill of Materials?*

Answer: CHFA will review all responses received and evaluate according to the criteria identified in the RFP.

# Question: Is the company that provided the assessment excluded from bidding on the implementation?

Answer: The company that provided the assessment is not excluded from bidding. All responses will be evaluated based on the evaluation criteria set forth in the RFP.

### Question: The following item cannot be ordered in the quantity of 1.

Answer: If there is a minimum quantity that must be ordered, the respondents should provide pricing for the minimum number that can be ordered.

# Question: Can you please provide shipping and delivery F.O.B. destination information and any special delivery instructions.

Answer: Hardware should be shipped to CHFA, 999 West Street, Rocky Hill, CT 06067 Monday through Friday between 8:30 a.m. and 4:30 p.m. (excluding state holidays).

Question: Is submitting a bid for the fiber cabling a requirement? Can firms submit proposals for some but not all of the sections?

Answer: Firms can submit pricing for one or more of the following: 1) equipment, 2) cabling upgrade, and/or 3) installation services.

### Question: Will CHFA consider a separate award for fiber cabling?

## Question: Can CHFA provide a floor plan, including square footage?
